### ECR 43576 Bank Deposit Number

*When saving a Cash Receipt, Non-AR Cash Receipt or POS payment, Adjutant will check whether that Bank Deposit # value has been cleared in Bank Reconciliation. If the Bank Deposit # has been cleared in Bank Reconciliation, an error message will alert users that the Bank Deposit # has been cleared in Bank Rec and will prevent it from being used.*

## Item Control (Inventory)

### ECR 43325 EDI 861 Editable PO Field

*The EDI Processing - 861 Tab - has been updated with an editable PO column which allows the user to edit to PO number associated with the 861 data.*

### ECR 43577 E-Commerce

*New logic has been added to support a new ECOMHIDE Item Attribute. Once ECOMHIDE is added to the Item Attributes (ITEMATTRIB) Rule Maintenance record and assigned to specific items, those items marked for resell will be hidden from any Ecommerce item searches.*

### ECR 43549 Sales Order Form

*The Sales Order form has new expressions available to print the associated contact details from the 'Contact' record tied to the sales order. The new SO Contact expressions are all formatted as 'other\_so\_XX' such as 'other\_so\_fullname' and 'other\_so\_emaila'. New expressions have been added for all of the primary contact fields from the Contact record.*

### ECR 43636 Print SO Form

*A surcharge expression has been added to the cursor for the Printed SO form that shows the credit card surcharge amount.*

### ECR 43524 Price Alert Message

*A new PRICEALERT Rule Maintenance record has been developed to prompt a warning message when any item added to a Sales Order falls below the defined percentage of the item's system price. The new warning is an alert and will not prevent the item from being added. The 'toaster' message will indicate which line number(s) fall below the defined control in the rule.*

This change affects the Adj2 PWO screen, Prompt 45 and 46, Connex Assembly logic and the AMS Assembly Logic.*

## Production

### ECR 43339 PWO Schedule Date

*A new option has been developed for the Sales Order Default Dates (SODATES) Rule Maintenance record that will default the PWO Schedule Date from the SO Load Date value. The new option available for the Date Type (Text1) setting in the rule is 'PWO Sch(L)'. The PWO Schedule Date can now be defaulted using either PWO Sch(A) which is based on the SO Add Date or PWO Sch(L) which is based on the SO Load Date. Only one of these option should be used to default the PWO Schedule Date.*

### ECR 43413 Project Scheduling Report

*This change adds a new 'Project Scheduling Report' to the Project Control screen that can be used to print a scheduling letter to be sent to customers. A new standard template is available for this report, but will require customization to design a report that matches each customer's needs. The new template is able to combine Task UDF details and task scheduled dates to create a customized report of scheduled tasks associated with the selected project.*

### ECR 43639 PO to SO Link Logging

*Additional logging has been added to the PO and SO linking process which should help with improved audit trail data around PO to SO links, link adds and deletes.*

## Shipping Events (Logistics)

### ECR 43186    Shipping Event Master

*The Shipping Event Master Trucks tab has been updated to show labels for the Truck Cartons information at the top of the screen and the Inner Cartons listed at the bottom of the screen.*

## System Manager

### ECR 43559    Adjutant 20/20 SMS Support

*Adjutant 20/20 now supports outbound SMS texts using the Twilio SMS Gateway. Enabling Twilio integration requires ABIS Development support.*

### **Setup Options**

Setup Options are system-wide controls that must be enabled/disabled in CID Maintenance. Some Setup Options will not display until the related application has been accessed. Contact your consultant for assistance with enabling/disabling Setup Options.

### **Rule Maintenance**

Rules are added or updated in the Rule Maintenance screen. If you are not familiar with adding or updating Rule Maintenance headers or details, contact your consultant for assistance.

### **Programs Affected**

Programs are system-level routines that must be updated manually by ABIS personnel. You must contact your consultant to coordinate updating the associated Program before taking advantage of the enhancement.

Program updates may require system downtime, or may be required to occur outside of business hours.
