ECR 43670 Mass Update - Attributes

New functionality has been added to the Mass Update tool that allows a user to add Organization Attributes to selected company records. Organization attributes need to be flagged to allow them to show up in the new update drop-down list for attributes. The Organization Attributes (ATT_ENT) rule must first be updated to define the logic 6 value for Mass Updates. Contact support for any assistance updating Rule Maintenance records if you are not familiar. Once the rule is updated, users will see drop-downs to select 'Attributes' and then select the attributes that should be added to the selected Customers in the Mass Update screen.

Users can now specify the number of shipping events that they want to create when using the 'New Shipping Event' button from a Project record. The new '# of Shipping Events' field in the pop-up dialog allows the user to specify the number of SE records to create and link to the project record.

A new CID Setup Option, POCHKAPINV, has been developed that will prevent edits or receipt returns on any Purchase Order (PO) line that has an AP Invoice linked. With the option enabled, for any PO line that has been been linked to an AP Invoice, users will see a message that the line has been linked to AP and can not be edited. If the linked AP Invoice is voided, users will be able to edit the line or process receipt returns through PO Receipts.

1. The new SEKEEPP setup option will maintain the same item tracking number (P#) value for lot-controlled and non-lot controlled items when entire quantities are loaded/unloaded on transfers and shipping events. This option only affects transactions where the entire lot quantity is moved.

2. The T# code for transfer line items is now available in the Post Load report. This new report data will allow users to customize the Post Load report for the T# value and generate bar codes on the report.

3. Prompt 78 will now recognize T codes for transfer line items so that users can unload an Interplant Transfer after it ships.

The new Project Status filter works with the Project completed status to enable filtering for open or completed project records. A new HIDEFROMBILLING Resource Attribute can be added to the ATT_RES Rule Maintenance record to prevent a specific resource from appearing in loaded records on the Approve/Edit Billing screen. New columns are available in the grid view to show additional project information.
