A new security token option has been developed to prevent changes to the Price Code on the Sold To attribute screen. The 'S1' value for the 'SOLDTO' Security Token can be set up as 'Disable Price Code'. If checked at the user security level, it will prevent that user from editing the Price Code field.

Approval Management

The AP Invoice Payment Priority code has been added to the Pending Approvals grid as an available column for reviewing and sorting by the payment priority code linked to an AP Invoice record.

A new CID Setup Option is available for customers using the SELINK logic. The new SELINKALLOC option, If enabled, will prevent auto linking lot controlled items to the SEs. This option will also split the lines up on the linking screen by allocated lot, and allow them to be linked by lot. Logic has been added to Prompt 79 to limit loading to linked lots. Add lotlink expression to SE Preload report. Update the SE shipping process to not delete the SOALLOCATION records until the SO is closed.

Setup Options

Setup Options are system-wide controls that must be enabled/disabled in CID Maintenance. Some Setup Options will not display until the related application has been accessed. Contact your consultant for assistance with enablling/disabling Setup Options.

Rule Maintenance

Rules are added or updated in the Rule Maintenance screen. If you are not familiar with adding or updating Rule Maintenance headers or details, contact your consultant for assistance.

Programs Affected

Programs are system-level routines that must be updated manually by ABIS personnel. You must contact your consultant to coordinate updating the associated Program before taking advantage of the enhancement.

Program updates may require system downtime, or may be required to occur outside of business hours.
