The attached AR Invoice PDF will now show the document type and the invoice number in the file name followed by a custom string of the date/time. The new file name will now show 'INV_123456_202410221200000001.PDF' indicating that Invoice #123456 was produced on 10/22/24 at 12:00.

<u>ECR 44274</u>	Finance Charges The Generate Finance Charges screen in Adjutant 20/20 will now respect the FCITEMINT CID Setup Option and use the '_INTEREST' Item Code rather than the system default Item of '_FINANCECHARGE.' If the FCITEMINT option is set and the _INTEREST Item Code does not exist, the system will attempt to use FINANCECHARGE and will fail if neither item exists.

Approval Management

ECR 44267 Approval Management

Approvals set up for Purchase Orders will now send a confirmation to both the Add User and the 'Buyer' on the purchase order when the order is approved or declined.

Additionally, new options have been added to the Approval Set up screen to include alerts to the approver. Approvers can be contacted via email or text when they have a new pending approval. Email alerts will use the approver's default contact email. Text alerts will use the Email2 filled out with the email to text format for their number (typically phonenumber@phonecarrierdomain.com).

Special note: A new version of Foxprocess must be installed to use the new approver alerts. Contact your consultant to receive the updated program version.

ECR 44173 Quotes/Sales Order Production Plant

A new CID Setup Option, NOHEADERPLANTCHANGE, has been developed for the specific case of changing an order's Shipping Warehouse where a user doesn't want the Production Plant to be changed to match. In this case, when a user answers 'No' to the prompts asking to 'Change Production Plant?' and 'Change Production Plant on All Items?', and the NOHEADERPLANTCHANGE option is enabled, the Plant on the order header will remain unchanged.

This new option bypasses the default reflexes of updating the Production Plant value on the order based on the Production Plant Priority settings for the Shipping Warehouse, which can confuse users that are attempting to override the Plant.

	The 'Questions to Exclude' (text4) value of the Quote Order Types (RFQTYPE) Rule Maintenance record will now work with the Adjutant 20/20 Quote form using the 'SOCDESC' form expression. Values entered in text4 will prevent the specified SOC Report Code values from printing with the SOCDESC expression. The SOCDESC2 expression will ignore these settings and print all SOC values. For example, to exclude Report Code 'A' and Report Code 'B' from Quote forms, you would enter !A!B! (note that the ! character is required at the beginning, between each value, and at the end) in text4 for the desired Quote type.

Setup Options	Setup Options are system-wide controls that must be enabled/disabled in CID Maintenance. Some Setup Options will not display until the related application has been accessed. Contact your consultant for assistance with enablling/disabling Setup Options.
Rule Maintenance	Rules are added or updated in the Rule Maintenance screen. If you are not familiar with adding or updating Rule Maintenance headers or details, contact your consultant for assistance.
Programs Affected	Programs are system-level routines that must be updated manually by ABIS personnel. You must contact your consultant to coordinate updating the associated Program before taking advantage of the enhancement.
